New Business

- **Sponsorship of Take Back the Night (S. Anderson/R. Queen)**
Susan Anderson presented the goals of the rally and encouraged the Faculty Senate's endorsement and faculty participation during the event (Thursday, March 31 - 7pm).
Faculty Senate approved sponsorship of the event.

- **2022-2023 Faculty Senate Elections**
 - Eric Kaufman introduced the process to elect officers and faculty senators.
 - Ran Jin discussed the calculated faculty senate seats for each department and the need to elect new senators. Office hours are available during the following week for senators who need clarification on what needs to be completed and the timeline for completion.
- **CFA 2021-22C: Resolution to Clarify Language in the Faculty Handbook Regarding Extending the Tenure and Continued Appointment Clock**
 - No comments or questions. Additional comments can be sent to the officers. If no comments are received the Faculty Senate will waive right to comment.
- **UC 2021-22B: Resolution to Rename the College of Architecture and Urban Studies to the College of Arts, Design, and Architecture**
 - Some senators pointed out that there was a lack of inclusiveness in the process to determine a new name for the college. The senators shared their frustrations but did not want to veto the content of the resolution.
 - Senators discussed whether the Faculty Senate comment was a good vehicle to share the concerns about the process.
 - Impacted senators will meet to decide if they are going to draft a comment with the goal of avoiding a similar situation in the future.

Open-Floor Discussion

- Update on the Commission on University Support (Jim Tokushia).
 - Google is moving from unlimited storage to a quota-based pricing model.
 - Based on the current storage usage by the University, it will cost over a million dollars to continue the Google service.
 - Google extended unlimited storage space for Virginia Tech through 2023.

- Bruce Pencek asked about the progress of the IT and software procurement. Robin Queen mentioned the IT transformation site which might include additional information. <https://svpcbo.vt.edu/Transformation-Initiative/ittransformation.html>
- A comment was shared that often the cause of delay was due to legal review.
- Evan Lavender-Smith provided a comment on short contracts (e.g., one year) for collegiate professors in various departments at the University. The suggestion was made for department

heads to review all collegiate rank faculty and ensure that contracts were written with three-, five-, or seven-year terms.
