- 2. Reminder of Faculty Senate Attendance Policy
 - Senators who will be absent from a Faculty Senate meeting should notify their alternate who should attend in their place. If there is no elected alternate, the senator should provide prior notice of their absence to any Faculty Senate officer. If a department or unit is not represented at two consecutive meetings without providing prior notice, the senator's department or college association will be notified. This process is intended to help departments ensure that they have adequate Faculty Senate representation. Further details can be found in the Faculty Senate Bylaws, Article III. Attendance.
- 3. Changes to Faculty Handbook
 - Ron Fricker, Vice Provost for Faculty Affairs, distributed a memo regarding changes made to the Faculty Handbook. These changes have been approved by the Board of Visitors.
 - The Vice Provosts' memo will be available on the Faculty Senate SharePoint site. The Faculty Handbook and webpage for the Office of the Executive Vice President and Provost will be updated to reflect the approved changes.
- 4. Overview and refresher on resolution workflow and process
 - An overview of the resolution workflow process, from planning stages through Board of Visitors review, was provided. Committees and commissions who are considering resolutions with human resources, legal or financial implications are encouraged to obtain HR, legal, and financial review before University Council Cabinet review. Virginia Tech's shared governance system is advisory to the president.
 - Details were provided regarding the Draft Notice process. Per the University Council Constitution, a draft of the resolution is required for University Council Cabinet review. Resolutions can be drafted by senates or committees,

but all resolutions must go through a commission. Additionally, individuals can draft a resolution, but a commission or committee affiliated with the Faculty Senate would need to take on the resolution for it to go through shared governance.

- 5. Elections were conducted for the remaining university governance vacancies. Results follow.

Open Floor Discussion

7. The Faculty Constituent Report to the Virginia Tech Board of Visitors was presented by Joe Merola and provided a global focus on items of concern for Virginia Tech

faculty including the need for transparent communication and concerns regarding compensation.

- Along with the written report, AI was used to generate a faculty constituency report to the Board of Visitors, and portions were read to BOV members. This report reflected many of the same concerns that had been previously presented. This AI-generated report will be available as part of the constituent report on the Faculty Senate web page.
- 8. United Campus Workers of Virginia Tech. A recent news article reported that there is now an employee union and a graduate student union at Virginia Tech. Main points of discussion follow.
 - Employees have a legal right to join a union. However, there are limits to what actions can be taken, such as collective bargaining. Any VT employee, excepting dean level or higher, may join the employee union. The union at Virginia Tech is one chapter of four in the Commonwealth (University of Virginia, William and Mary, and Virginia Commonwealth University have chapters). An interest meeting will be held on September 21. Union dues are required to join the union and are based on salary.
