Approval of Agenda

John Ferris noted that Bob Hicok is unable to be present due to illness. Accordingly, the previously shared agenda was amended, delaying discussion of Faculty Handbook edits to a future meeting. The new agenda was approved by unanimous consent.

Approval of Minutes

Minutes of January 24th meeting were approved.

Announcements

- Eric Kaufman highlighted the need for more faculty to serve on Graduate Honor System (GHS) panels. Additional information is available on the GHS website: https://graduateschool.vt.edu/academics/expectations/graduate-honor-system.html
- Eric Kaufman encouraged senators to provide input on the library's presence with the Innovation Campus. Eric is serving as the Faculty Senate representative to the Library Committee, and that committee is gathering input to prepare a statement about what is needed for library services at the Innovation Campus.
- John Ferris requested input on milestones and metrics for measuring faculty/ university impact. The issue is that measures of Virginia Tech's strategic priorities are being considered that may not align with faculty views. He requested measures (i.e., numbers and equations) that could be shared at the Presidential Council Retreat on February 11th. John noted that President Sands seems to prefers figures of merit that present a ratio of two data points. John also shared correspondence from Provost Clarke about Times Higher Education (THE) impact ratings, including recent alignment with the United Nations Sustainable Development Goals. - John Ferris shared an update related to the College of Architecture and Urban Studies:
 - The Provost met with A+D faculty in Blacksburg and is scheduled to meet with WAAC faculty in Alexandria. During the meeting, the Provost reviewed faculty concerns that were shared directly with him and through the Faculty Senate and updated attendees on actions related to each. Reese Ramos, VT ombuds, also

attended the meeting and has offered to facilitate conversations between faculty and Dean Blythe, which the Provost has strongly encouraged.

Topic 1: Sesquicentennial Celebration

- Rosemary Blieszner provided an update related to Virginia Tech's Sesquicentennial celebration (Appendix A). This is a significant milestone, and the celebration is intended to be complementary to the Beyond Boundaries initiatives.
- There are already faculty representatives on the planning committee. Broad involvement is desired. The committee is working to develop materials that allow individual units to hold related activities.
- There may be an opportunity for the Faculty Senate to highlight both the history and vision for governance at Virginia Tech.

Topic 2: Undergraduate Enrollment

- John Ferris provided an update related to admissions and undergraduate enrollment forecasting. The individuals working on this have been forthcoming with the data, as well as yield models. While many changes were made last year, very little has changed for this year, which allows more confidence in the forecasts. One change is a small adjustment in the proposed yield rate for the College of Engineering. In other areas, there is less than a 1% difference in the numbers.
- Virginia Tech's target number of acceptances this year is 6,675. John estimates the actual yield will be about 2% below this estimate, but this is acceptable in the ebb and flow of enrollment from year to year.
- One policy change this year is that early-decision students are no longer obligated to stick with their decision (they can be poached from other universities). Also, shifting relations with China could slightly reduce international enrollment. In contrast, an increase in campus visits could slightly boost enrollment.
- In sum, John believes there is no reason to be alarmed.

Other Business/Discussion

- The Engineering Faculty Organization (EFO) recently conducted a survey, following up on concerns raised by the Faculty Senate's Report on Research Assessment and Salary. The Engineering faculty's participation in the report was initially minimal, so the EFO sought additional input from College of Engineering (COE) faculty. A senator noted some of the phrasing was odd, but appreciated the EFO's efforts to gain input. An EFO representative (Ashley Johnson) encouraged more input and feedback, allowing the EFO to better represent a broad range of faculty within COE. This aligns with some of Faculty Senate's efforts to strengthen college faculty associations.
- No other business was presented.
