1 Introduction of Officers

Officers each completed a brief introduction of who they are and description of their roles in Faculty Senate this year. Introduction order was Robin Queen (Faculty Senate – VP), Ran Jin (Faculty Senate – Operations Officer), and Robert Weiss (Faculty Senate President).

4 2021-2022 Faculty Senate Goals

Governance Model Transition

Robert presented a brief overview of the work of the President's Council on Governance (PCG) and the work that the Faculty Senate will be doing over the next year to advance the shared governance changes.

- Brief description of the commissions that would report through the Faculty Senate.
- Additionally, it was explained that the Faculty Senate would be hearing more presentations from additional members of the PCG throughout the year.
- Robert and Robin will initiate office hours for all Faculty and send our campus announcements with details.
- Expectations from the Senators: it is important to participate in the faculty senate as senators and improve the two-way communications between the faculty and the faculty senate.

• Experiential Learning

Robert provided a brief update on experiential learning and the importance of this initiative to the administration. The goal is to embed experiential learning into the programs across campus.

Faculty Senate Task Forces

Robert described the process by which he would like to bring together small groups of faculty (senators or others) who have expertise in specific subject areas.

- The ask of these small groups (task forces) would be to provide insight and guidance to the Faculty Senate leadership.
- This could be short term projects (few days) and potentially longer-term projects in which the group will need to continue to meet and work with Faculty Senate leaders to develop potential responses and solutions to challenges.

Statements:

- The additional topic about faculty senate statements was included in this discussion.
- The goal of these statements is to do two things: (1) provide a unified Faculty Senate opinion related to topics of importance in the external landscape (example the impact of critical race theory on academic freedom, and (2) provide a unified Faculty Senate opinion related to topics of importance specifically within the Virginia Tech community. For the internal challenges, the proposed plan was for a group of individuals to take the result of a conversation in Faculty Senate and all the associated comments and then generate a statement that could be reviewed by the entire Faculty Senate and be modified in an iterative process which will ultimately lead to a vote by the Faculty Senate to approve the statement prior to its release.

Additional Goal Ideas (Max 20 minutes)

Robert led a discussion regarding additional goals for the Faculty Senate for the coming year. Below are listed the additional goals that were mentioned.

- Addressing work/life balance and the impact of school closures as well as the need
 for flexibility depending on life situations as well as recognizing the differential
 impact this can have based on career stage, sex, and race this topic was raised by
 multiple senators. A more thoughtful and intentional development of various
 committees and task forces and the need to make these groups more
 representational The impact of masking on teaching of foreign languages and the
 need for small group with and a need for greater flexibility for the use of
 synchronous online teaching
- Work with the administration to alter the narrative regarding COVID-19 and the need for vaccinations and how the current messaging is resulting in increased stress and fear for many in the community.
- Request that the Faculty Senate pushes for the addition of another team member for the Honors system to expedite the cases being resolved.
- Multiple concerns raised regarding flexibility in teaching and learning modalities and the desired to have more conversations with administration regarding the autonomy of faculty and graduate students to make these decisions and the need to develop a faculty senate statement.
- Request to have a statement from the Provost's office that faculty are not required to provide multiple learning modes for students so that faculty are comfortable with saying no when students request additional modes of learning.
- Request to gain clarity into the process for defining medical and religious beliefs and who will be making these determinations when it comes to vaccine exemptions.
- Remain engaged with the discussions regarding increasing undergraduate student enrollment and what this means for faculty workloads making sure to reference some statements that were provided to the Board of Visitors in 2019.

• Request to review the committee and governance representation requirements and determine if there are any ways to decrease the workload, which is especially challenging for some of the smaller colleges.

5 Commission on Faculty Affairs (1 Position) Election

- Open Call for nominations: No additional nominations were received
- Candidate 1: Eric Kaufman (CALS Agricultural, Leadership, and Community Education)

Voting was completed electronically with the following outcome: Yes: 66, Abstain: 1 (No other candidates). Eric Kaufman is elected as the Faculty Senate representative in the Commission on Faculty Affairs.

The caucuses from each college met and selected the senator who would serve as a member of the Faculty Senate cabinet. Two colleges were not able to select cabinet representatives during the meeting given their small number of participants from their college.

Robin will follow up with the two caucuses on Monday to request that the caucus determines the senator that will serve as a member of the cabinet.

7 Open Floor Discussion

Robert recognized Ashley Shew to present her request to the members of the Faculty Senate.

 Ashley provided <u>an open letter</u> to the Virginia Tech administration regarding concerns about safe teaching environments for those with underlying conditions and concerns. Ashley Shew also provided a link to <u>notes</u> providing specific examples and concerns.

- Ashley read some of the open letter to the Senate as well as some notes related to the individual impact of some current VT policies and asked that Senators consider signing the attached letter indicating the individual senator's support for the document.
- A series of specific requests were presented by Amy Nelson.
- A motion was made by Jim Tokuhisa to have Faculty Senate endorse the Open Letter to the VT administration.
- The motion was seconded by Richard Shryock.
- Discussion regarding the motion on the floor and no consensus was reached. Concerns
 were raised over the rushed vote and the need to review the documents more carefully
 before voting to make an informed decision.
- Discussion regarding potential other options for the motion and being able to write a statement in support of the ideas without voting specifically on this motion.
- Motion was withdrawn by Jim Tokuhisa.
- Additional discussion regarding the potential to vote electronically following the meeting
 to allow others to have time to read and think about the document and their comfort in
 signing the open letter.
- Susanna Rinehart made a motion for the Faculty Senate to endorse the Open Letter to the VT leadership and to request that this vote happen over the coming weekend.
- Jim Tokuhisa seconded the motion.
- Based on the discussion an email will be sent to all faculty senators with the link to the open letter for review as well as a link to vote (yes/no/abstain) on whether the faculty senate, as a body, officially endorses the open letter to support safe working and learning environments at Virginia Tech.

The two additional topics for open discussion will be moved to the agenda for September 3, 2021.

Motion was made to adjourn the meeting and seconded.

The meeting was adjourned at 4:36pm.
